Permissions – Pricing Principles

Updated: 16 October 2013

The following fees apply to the reproduction of Law Society copyright materials in print, CD or eBook formats for one edition only or for loose-leaf or online formats for one year only.

The permission fee is the same for each format. The fee is doubled if you intend to reproduce material in two or more formats. However, if the material is to be reproduced in both print and eBook formats then the total fee is for print reproduction plus an additional 10%.

A 50% discount applies for educational establishments.

A minimum charge of £100 applies other than for items listed as “FREE”.

Strategic Research Unit material, e.g. Trends in the Solicitors Profession Annual Statistical Report	FREE up to half page or single table/graph, £100 minimum charge for series of extracts, no more than 10% of the whole report to be reproduced.
